Submission Deadline	:	Friday, February 21, 2025 by 1100 hours;
EOIs Opening	:	In first step, the envelops of Technical Bids shall be opened (for technical evaluation) at 12:00 hours on February 21, 2025 at ICMA's Faisalabad Office in the presence of contractors or their authorized representatives. In second step, Financial Bids (of those bidders who secure above 50% numbers) shall be opened (in front of bidders or their authorized representatives) after compilation / evaluation of Technical Bids. Date and time for opening of Financial Bids will be announced/ communicated to bidders accordingly.
