The scheme will allow all Pakistani citizens (except public office holders and their spouses) to declare their hidden domestic and offshore assets after paying certain tax.**

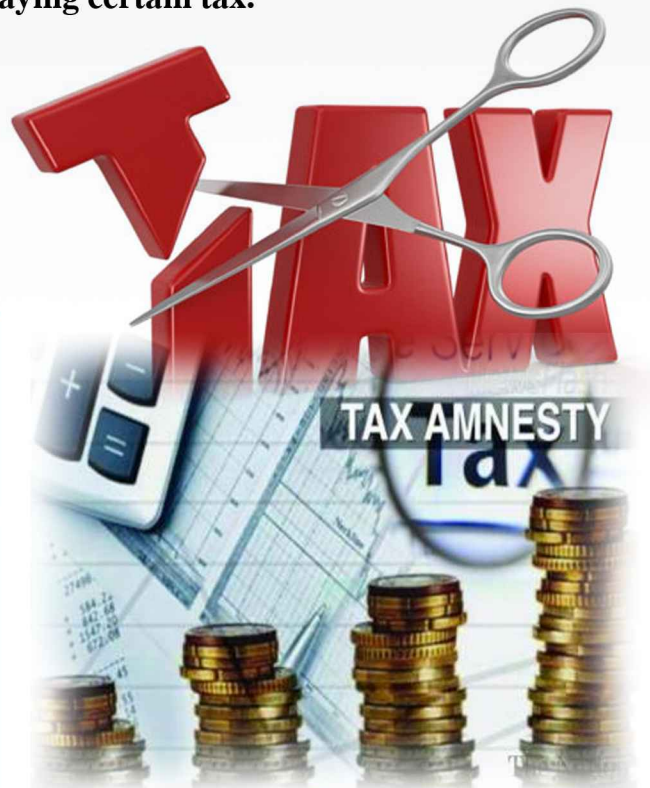
