The Government of Pakistan has promulgated recently many ammendment in The Income Tax Rules 2002, The Sales Tax Rules 2006, by issuing:

SRO 350 of 2024 to establish a critical link between buyer's tax return filing and their suppliers' compliance.

SRO 457 of 2024 to Introduce "Tajir Dost Scheme" Special Procedure for Small Traders and Shopkeepers,

Proposed Draft Amendments in the Income Tax Ordinance, 2001 was also issued to abolish the forum of the first appeal i.e. Commissioner IR (Appeals) under the Income Tax Ordinance 2001, Sales Tax Act 1990 and Federal Excise Act 2005.
